Descendants of Joseph Patchen, Sr.

Generation No. 1

1. JOSEPH¹ PATCHEN, SR.¹ was born Abt. 1610, and died December 10, 1689 in Fairfield County, CT. He married (1) ELIZABETH JANE IGGLEDEN¹ April 10, 1642 in Roxbury, Essex County, MA¹. She was born 1602 in Biddenden County, Kent on the Castle, England, and died March 10, 1679/80 in Roxbury, Essex County, MA. He married (2) MARY MOREHOUSE¹ 1662¹. She was born 1638 in Wethersfield, Hartford County, CT.

Notes of John Patchen, President of Family Association.

"Joseph testified as Joseph Sr. age 56 in the Benfield Case, May 1, 1666.

'Nov, 1651 Benjamin Child witnessed a deed for ten acres and a half sold by Joseph Patchin of Roxbury to John Dane of the same town (Suff. Deed, 1:145, in Linzee's History of Peter Parker and Sarah Ruggles of Roxbury, Mass, p. 382.'

'He removed to Fairfield by 1652, was granted a home lot 1655/6, and was one of four "poor men" whose debts were forgiven by Dr. Pell in his will 1669 (this may have been for medical services). He was living 1689 when his son was still "Jr." '

'His second wife also testified in the Benfield Case, 1666. Much of his property in Fairfield came into possession of the Edward Adams family, probably not inheritance. Quite likely there was a relationship, but just what we cannot say; Patchen realty may have been turned over to the Adamases in return for maintenance.'

'His two sons accompanied him to Fairfield, Conn., by 1652 where he was granted the home lot on Jan 29, 1655, in 1658 styled as "Joseph Patchen, Sr." and in list of Fairfield landowners from 1649/52. Bought land Apr 22 and Apr 28, 1658, July 12, 1666, Oct 3, 1672, Oct 2, 1672, Oct 4, 1672, May 11, 1681, Nov 9, 1684 (land holder in Stratford, Conn., from Dec. 1668-1671).'

'Sold land Apr 23, 1671, Oct 3 and 4, 1672, May 23, 1679, Feb. 24, 1681. The title Jr. does not appear until after 1681 when Joseph, Sr. sells and disappears from the records. Then Joseph Patchin sells land jointly with Joseph Middlebrook, one acre, 1686.'

'Schencks's History of Fairfield, Conn. p. 329, No. VI, mentions Joseph Patchin, 334, 1670/1, Patchin Estate, 60-195 acres, 336, building lot and pasture to Joseph Patchin, Sr. 4 and 3 acres, 337, grant of part of Old Indian field, 8 acres, Joseph Patchin, 339, division of lots at Compo Neck, Lot #76, 60 acres. Joseph 346, Jacob Patchin freeman Mar. 1689/90.'

'Banks--Topographical Dictionary of 1885--English Emigrants to New England 1620-1650 p. 74 Patchen, Joseph, from Ashford in Kent, in ship Hercules. Banks--Planters of the Commonwealth, Passengers and Ships, p. 116. In Ship Hercules, of Sandwich, John Witherly, Master, 1634. Sailed in the spring of this year.'

'Elizabeth Iggleston (Bennet) brought a son, John, with her and married Joseph Patchen; Our suggestion is that John Iggleston of Fairfield was Patchen's stepson. On 29 Oct 1646 Egheden, Step daughter to Joseph about 10 years old died New England Historical & Genealogical Register v. 65 p. 187.' Elizabeth Iggleston's son John became Joseph Patchen's stepson.'

'Joseph, Jr., 1680, was appointed to sweep the meeting house. Inventory 1 Dec, 1689; estate insolvent; no land; clothing and tobacco at house of Nathan Adams; Administration granted to Jonathan Morehouse. (Fairfield Probate Records, V. 3:299) Henry B. Betts of Danbury wrote, Aug 16, 1911., "in land issue of the Hartford

Times, a correspondent familiar with Fairfield Records says--also repeated references land rec) show that the second Joseph Patchen who was unmarried and not bright, died at the home of Nathan Adams and the Adams families took his estate"

'Oct 26, 1692, Robert Silliman and Nathan Adams exchange land, lots to run back to land once the property of Edward Adams and Joseph Patchen, both deceased, now owned by Nathan Adams, Fairfield L.R. v. A:355. Abraham, Nathan, Daniel, David and John Adams and Luke Guire, son in law of Edward Adams, divide land of Edward Adams and Joseph Patchen, *ibid* v 3: 227, Jan 21, 1713/14, have land laid out to Joseph Patchen and agree to divide part of long lots that were Edward Adams and Joseph Patchen's. *ibid* v. 3:395.'

'Joseph Patchen, Jr. hath made application to the Townsmen, Apr 27, 1681; he hath a house and land in Fairfield but wants Town help in improving same. *ibid* v. 3:395.

'Town paid for his funeral expenses, and on Dec. 10 1689, estate pronounced insolvent, but on Oct 26, 1692 when James Everts buys land of Joseph Patchen, Sr. now land of Nathan Adams, one of the boundaries is the "land of Joseph Patchen, Jr., deceased, now the land of Nathan Adams, " no lands on probate record. Everts buys 1/2 acre of Joseph Patchen's home lot, bounded on the north by the Milne Pond, formerly land of Joseph Patchen, Jr. dec.'

'Rebecca, wife of Daniel, Samuel, Edward Adams may have been dau of John Cable, if so, then aunt of Margery and Abigail Cable, who married gransons of Jospheh Patchen, Sr. Also, descendants of Thomas Morehouse married into the Patchen family at least fourteen times.'

'Sometime before 4 Oct. 1672, Jonathan, son of Thomas Morehouse, purchased from Joseph Patchen, Sr. his house on Wolf Pit Plain which sometime had pretayned to Thomas Morehouse. By Mar 22, 1681 he had purchased from Joseph Patchen, Sr. all his interests within the bounds of Fairfield.'

'The first Wolfpit Plain was Sea Side Park formerly owned by the Sasquam Indians.'

'John Patchen living a poor old man at Stratfield in 1712 when he was provided for in will of Isaac.' Wheeler, whose servant he had been for thirty years.'"

Notes provided by Rick and Tamie Crist:

"He married twice. He married Mary Morehouse. Mary was born in Biddenden, Kent, England 1638. Mary was the daughter of Thomas Morehouse. He married Elizabeth Bennett in Roxbury, Essex County, MA, 18 April 1642. Elizabeth was born 1612. According to New England Historical and Genealogical Register, his first wife came from Biddenden Co., Kent on the Castle, in 1638 with husband Stephen and children, of whom the former died on the passage. Another passenger died at sea and left money to Elizabeth for her care of him. Jacobus, in The Families of Old Fairfield II part 9, p. 1077 states that The New England Historical and Genealogical Register is wrong. Elizabeth Iggleden, not his widow came to New England. She came with children Jane, Sarah and John as members of the household of Thomas Besbeech of Ashford." Elizabeth Iggleden's son John became Joseph Patchen's stepson."

2. SR. JACOB² PATCHEN (*JOSEPH*¹)¹ was born Abt. 1663 in Fairfield, Fairfield County, CT, and died February 15, 1748/49 in Wilton, Fairfield County, CT. He married MARY HUBBARD¹ 1692 in Fairfield County, CT¹. She was born 1668 in Fairfield, Fairfield County, CT, and died March 25, 1754 in Wilton, Fairfield County, CT.

Notes for SR. JACOB PATCHEN:

Note from John Patchen, President.

"Jacob Patchen was made freeman 18 Mar 1692 and was appointed administrator of the estate of Samuel Grumman, late of Fairfield. (John Patchen/Pres. of Assn.) 1692.'

'Samuel Adams purchased from Jacob Patchen, with consent of his wife, part of the long lot laid out to John Grumman dec'd. 24 Mar, 1694/5, his wife renewed her covenant, and August 3, 1746 admitted to full communion; March 24, 1694/5/ her daughter, Mary Grumman, was baptized, with Joseph and Abigail Patchen, children of her second marriage.'

'The will of William Hubbard, dated October 10, 1702, probated Nov 25, 1702, reads, in part:

"I William Hubbard give my son in law Jacob Patchen my cloak and the clothes I now have on and the best pair of shoes I have. And to my daughter Mary Patchen the bed I lie on and the appurtenances thereto...All residue one half to Daughter Mary Patchen and one half to daughter Sara Bennit. I give unto my son in law Thomas Bennit. I give unto my son William Hubbard meadows at Greenwich."

'As there are several mentions made of Jacob Patchen in the Fairfield Church records, we give them as of interest to his descendants, although as he had moved to Norwalk, Wilton Parish, before Nov. 13, 1746, on which date he "of Norwalk" conveyed to son Jacob land in Fairfield, the subsequent dates probably refer to Jacob, Jr., although Jacob, Sr. may have continued in the Fairfield Church.

March 11, 1727, Jacob Patchen to be seated in the third long seat in meeting house; Mar 2, 1730. "the society did agree to give Jacob Patchen 8 pounds 15 shillings he finding Mr. Sturgeon a sofiscent suply of firewood for year insewing; Dec 7, 1733, Jacob Patchen to be Seated in Second long Seat," Jan 9, 1744, Society made choice of Jacob Patchin to collect ye Society rate and have 19 shillings for his trouble also minister's rate and have for his trouble 14 shillings; "Dec 19, 1745, "Jacob Patchin to collect minister's rate and to have 35 shillings as a reward for gathering sd. rate; "Dec 17, 1747," it was voted to gfive Jacob Patchin one hundred and fifty pounds old tennor to finish their meeting House Galeryes agreeable unto ye Lord's work, "July 14, 1749," The Society by their vote Say they will give Jacob Patchen for his Losse in the meeting house thirty five pounds; ":Dec 1, 1749" it was voted that the thirty five pounds given Jacob Patchen be put in Mr. Gaylord's rate and gathered by sd. collector; "a Jacob Ptchen died Feb 15, 1750, aged about 88 years, a Jacob Patchin died 4 April 1764, aged about 60 years.'

'New Meeting house "galleries were finished by Jacob Patchen in 1747 with good white wood and white oak boards"Olmstead, p. 21, 28 Dec, 1752, Mr. Jacob Patchin on School Committee; Dec. 12 1757, Jacob Patchin on committee to adjust accounts in respect to a pound (for stray cattle) near Split Rock.'

Notes from John Patchen, President:

"Joseph Patchen removed to Wilton, Conn., 1729, where he and his wife joined the church, Feb. 13, 1732. Norwalk Land Records show that on May 16, 1729 Matthew and John Seymour of Norwalk for 125 pounds, sell to Joseph Patching of Wilton Parish, four acres on the east side of Pimpowaug River; witnesses, John Copp, Samuel Finch (6:323). Joseph and Martha Patchen sell "to our loving son Nathaniel Nott the house we now live in"; rec. Apr 8, 1768. Sep. 6, 1781, Joshua Couch of Fairfield for 100 Pounds, sells to Martha Patchen, wife of Joseph Patchen of Fairfield, land next William Sterling's land, which he purchased of Joseph Patchen (14:423)."

Mar 4, 1723, Joseph Patchen agreed to care for Phebe Bennit (until she is 28), daughter of John Bennit, relieving her mother of all care, and was to receive land in payment for care.

The Veterans Administration, Washington, D.C., gives the following data obtained from papers on Zebulon Patchen.

"He enlisted into the military in Lebanon, Columbia County, NY, 15 Aug 1779 in Col. Robert Van Rensselaer's NY Regiment, was discharged Nov. 25, 1779, living in Lebanon Springs. His widow was allowed bounty land in full satisfaction for the services rendered on her application executed 29 Nov 1856, at which time she was aged 74 and a resident of Clay, NY. Bounty Land Warrant. File No. B.L. Wt. 61260-160-55. Cert. No. Issued Act of 3 Mar 1855. App. for Bty. Land 29 Nov. 1856. Age 74 (Polly). Residence at date of App. Clay, Onondaga County, NY.

9 Nov. 1856 Onondaga County, NY Declaration of Polly Patchen, aged 74, resident of Clay, Onondaga County, NY is widow of Zebulon Patchin, deceased, a private in Capt. Gideon King's Co, NY Militia Regiment, commanded by Col. Robert Van Rensselaer in American Revolutionary War; her husband was called out with said company at Lebanon about 15 Aug 1779 for one year and continued in actual service 3 months, and was discharge din Nov. 1779.

She was married to said Zebulon Patchin in Lebanon, June 17, 1798 by Elder Drake a clergyman and her name before said marriage was Polly Cohoon. Her said husband died at Clay aforementioned on April 6, 1847 and she is still his widow.

24 Oct, 1856 Certificate of Comptrollers Office, NY shows: "Zebulon Patchin, Private, Book 8, certificate No. 36882, dated Nov. 25, f3 9s 4d.; Capt. Gideon King, Col. Robert Van Rensselaer."

The affidavits of Smith Lynn and Charles W. Cohoon of Clay, NY declare that the above declaration was signed and acknowledged by Polly Patchin in their presence, and they believe that she is the identical person that she represents herself to be. Peter Young, Justice of the Peace, certifies that he knows the affiants.

25 November Onondaga County aforesaid. Deposition of Jefferson Freeman, of said Clay, states that he was well acquainted with Zebulon Patchin, deceased, late of Clay and is well acquainted with Polly Patchin, his widow, and has been acquainted with them since 1828 until the death of said Zebulon in 1847. Said Zebulon and Polly lived together as husband and wife until his death and they raised a large family of children as such; Said Zebulon was a man of highest character for truth and veracity, and was accepted and believed to be husband and wife in the community where he lived, and deponent was his neighbor and of Polly Patchin during said period and was well acquainted with them and she is still a widow.

Dec 8, 1856 Deposition of Horatio Warner, of said Clay states that he was well acquainted with Zebulon Patchin deceased who died at said Clay 6 April 1847 the deponent was present and preached the funeral sermon of said Zebulon Patchin. Deponent was acquainted with Zebulon Patchin more than 30 years, and has heard him frequently relate the circumstances of his revolutionary military services, and he was considered a man of a strict truth and veracity, and deponent always placed full confidence in his statements; deponent is

also acquainted with his widow who now resides in Clay and is still a widow.

25 Nov. 1856, Deposition of James Lynn of said Clay, had known Zebulon 40 years, was present and witnessed his death 6 April 1847 was a neighbor also knew their children now grown men and women, the youngest 40 years of age. Often heard Zebulon relate his military experience.

25 May 1857, Deposition of John Patchin, 67 years old, of Amboy, Onondaga County, NY. Became acquainted with Zebulon and Polly about the year 1795 when they resided at Lebanon Springs, Columbia County, NY. Often heard Zebulon speak of his Revolutionary services particularly his march to Fort Stanwix, following up the retreat of the British and the Tories from Fort Stanwix, which he witnessed. Deponent worked for Hezekiah King, son of Capt. King died at home of his son Hezekiah and left all his papers there, together with the roll of his Company on which he saw the name of Zebulon Patchin; that Zebulon Patchin married Polly Patchin about one mile north of New Lebanon Springs, that he came to live in Greenwich in June, 1800; that the present Polly Patchin of Onondaga County is the widow of Zebulon who served in Capt. King's Company in the Revolutionary War.
